



## where can i apply for deposit etc

How do I get an ETC card? Log in to your credit card's online portal or visit a branch to request an ETC card. Fill out the necessary forms, providing basic details like your name, address, and credit card information. Most applications are quick and straightforward. Upon approval, your ETC card will be mailed to your registered address, usually within 1-2 weeks.

What is an application deposit? An application deposit is a lump sum that a landlord or property manager will require you to pay when submitting an application for a rental property. Some landlords and property managers require an application deposit as a sort of guarantee that an applicant will follow through and rent the apartment after their application is approved.

How do I apply for an ETC card without leaving home? Most operate between a.m. and p.m., seven days a week. You can also apply without leaving home by calling the ETC Personal Card Issuing Office at 044-870- between a.m. and p.m. on weekdays. You can also visit their website but you will need browser translations or Japanese skill to navigate.

How do I get etc insurance? Use the forms on the ETC website for either your car or motorcycle. As of , they also have an online application form. Then, bring your filled form, driver's license, and car registration to the shop. Also be aware that you need to have your ETC reader, and the car's shaken (??) insurance paperwork.

How do I top up my etc card? There are 3 ways to top up your ETC card. 1. With cash or your bank card with UniPay logo on, you can top up at the ETC offices. 2. With cash or your bank card with UniPay logo on, you can top up at the rest areas. 3. Every time you top up your ETC card, the minimum amount is 50 RMB
